Around the Traps – What's going on in the Community?

I have often spoken about the importance of **holistically** addressing how A-SPEC fits into existing processes with asset owners and consultants. If A-SPEC is the start then what's next?

Sharing experiences is the worth of participating in the A-SPEC Knowledge Sharing Community.

Our objective is to have conversations and many of them and often with the A-SPEC Community stakeholders. Whether they be with asset management vendors, surveyors, engineers, landscape architects, council and water authority asset owners or other software vendors.

Our experience of late has been that the conversation is the same. How do we guarantee that what we receive is what we expect from A-SPEC and can fit into our systems? AND from the other side of the fence – how can we guarantee that every A-SPEC member will be consistent?

Firstly let's unfold the question from the asset owner's perspective. I will address the industry question in the next newsletter.

A smart man once said "The secret to success is still a secret!"

So if that's the case, then, let's look at the actions that can be taken to set up our structures for fulfillment and let's look at them as a series of questions for consideration.

- Have expectations been clearly identified and agreed to?
- Are the expectations clearly reflected in your relevant workflows?
- Have you satisfied yourselves that the company delivering the data can give you certainty about what you are receiving?
- Do you know where the data will end up not just which system but the structure?
- Do you have rigour around your processes for communicating and resolving non-compliance?
- Have specific dates been defined for deliverables?
- Does this fit within your Corporate Governance Framework for Quality Data?

Based on our experience, everything can be resolved in communication. If you are unclear about any aspect please contact the relevant person and if you don't know who that is then maybe someone in your network knows who that is.



New COVID Efficient Practice

The ancient Greek philosopher Plato said "Necessity is the mother of invention".

Like other organisations we have embraced the online technology to provide us with the opportunity to deliver our services to our clients. How this played out is that two recent projects enables us to undertake user needs interviews and workshops online (both traditionally face to face activities where you can read body language and engage directly) and you know we got our results with a minimum of fuss or drama.

COVID is certainly enabling a new business practice out of necessity. Our future projects are now scheduled to utilise this method.

Digital Hive







We reported in our May news that Digital Hive, one of our joint venture businesses started delivering QGIS – A-SPEC training courses online. This is a 2 day program specifically designed to utilise the capability of QGIS to validate and output A-SPEC compliant asset data. You can now book yourself and your team into a date that works for you.

The training is run over the 2 days for 4 hours each day. "The exercises are designed to highlight the importance of digital data so that you have the ability to confidently and quickly go through and check that the data is correct and makes sense in the real world" said Mary Rabling of Absolute Surveying. "I now understand the capability of QGIS to increase our productivity. In the meantime I am still getting used to working remotely" she continued.

Training programs will run the first Tuesday and Wednesday of each month. There are only 6 places for each training program. The next program is on 4th & 5th August 2020 and there are 2 places remaining.

When do I record Bollards as a Fence or a Traffic Management Device?

Another great question. This is one of the most common questions we receive.

At a previous Forum it was agreed that if Bollards were installed in areas of Public Open Space to depict a fence perimeter then this would be shown as a Fence and Fence/Wall Type would be Bollards.

If Bollards were installed for example on a Median Strip or at the entry to a Lane Way then these would be captured as a Traffic Management Device (Point).

The number of FAQ's is increasing. We are being requested to provide guidance on the capture requirements and have commenced looking at the structure of our guidance and practice notes and how we will communicate them to the Community.
